

# **MEDICAL EMERGENCY RESPONSE PLAN CHICOPEE HIGH SCHOOL**

Activation of Emergency System (post by all phones)

**TO CONTACT THE SCHOOL NURSE IN A MEDICAL EMERGENCY  
CHOOSE ONE OF THE FOLLOWING:**

- Dial the school nurse at Ext. 2117 or 2143.
- Call over the walkie talkie for “# 17”
- Call Direct line: 594-3471

In a life-threatening emergency or for immediate police assistance, contact the main office, Dial 0 from your classroom phone. The main office will call 911.

When necessary for outside police, fire, or EMT to respond to a medical site the static response time is 2-5 minutes.

In all cases, be prepared to state your name, the victim’s name, your location and nature of your emergency.

If a student’s behavior is escalating, call for school resource officer (SRO):

- (SRO) Officer Johnny Jusino on the radio (unit 11) immediately.
- Notify main office (Dial 0) and request SRO immediately go to location

## **LOCATION OF EMERGENCY DEVICES**

Automated External Defibrillators (AEDs) are located on floors 1, 2, 3 and 4 across from room 119, 219, 319 and 419 respectively. There is also one located at the Community Entrance (Exit D) outside the gym bathrooms. The athletic trainer has an AED on his/her person during sporting events. All police, fire, EMTs responding to a medical emergency carry AEDs with them

Extra Epi-pens are located in the unlocked, orange, emergency box on top of the file cabinet in the hallway of the clinic.

## **AFTER SCHOOL HOURS**

There is a nurse in the building until 4pm. After the nurse leaves if there is an emergency please DIAL 9-911.

If there is a sports injury after school, call the ATHLETIC TRAINER, (Kelly Levesque) at Ext. 2285 or on her cell phone 413-887-9793.
